**Q** How much money can be transferred to the Rainy Day fund during the year?

**A** IC 36-1-8-5.1 provides that in any fiscal year a city or a town may transfer to the rainy day fund not more than ten percent (10%) of the city or town's total annual budget adopted under IC 6-1.1-17. The annual budget amount would be their city or town's total annual budget approved by the Department of Local Government Finance (DLGF). The DLGF has advised any transfers from a dormant fund to the rainy day fund would also be subject to this ten percent (10%) limitation.
