

tive Committee since 2018, and Aim's Legislative Committee since 2019.




**Q** Does the money received for the American Rescue Plan Act (ARPA) that is receipted into a separate ARPA fund require appropriation? If so, what are those steps?

**A .** The appropriation process for the ARPA Fund is the same as for any home-ruled fund as defined by the Department of Local Government Finance (DLGF). IC 6-1.1-18-5(d) provides "A political subdivision may make an additional appropriation without approval of the department of local government finance if the additional appropriation is made from a fund that is not described under subsection (b). However, the fiscal officer of the political subdivision shall report the additional appropriation to the department of local government finance." It is our audit position that the ARPA Fund is a "fund that is not described under subsection (b)."

To use ARPA funds in 2021, follow the additional appropriation process in IC 6-1.1-18 which is described in the DLGF Memorandum, *Additional Appropriation Submission, Department Review Procedures, and Other Related Topics*, dated February 5, 2021. Additional appropriation procedures for home-ruled funds require public notice, a public hearing, and reporting to the DLGF. The ARPA fund is considered a home-ruled fund for DLGF purposes. To use ARPA money in 2022, it is our understanding that the ARPA money should be included in the normal budgeting process, including the advertisement and adoption of appropriation.

## Indiana League of Municipal Clerks and Treasurers



Dear Friends and Colleagues:

The ILMCT Legislative Committee is pleased to file this final report from the administration of Past President Karen McQueen to our colleagues in the League. We have been pleased to have been joined by our wonderful partners from Aim, in moving forward the League's goal to make existing good policy still better.

The session just ended-- styled as the first regular session 2021 of the 122<sup>nd</sup> Indiana General Assembly -- was busier and more prodigious than this Co-Chair Griffin supposed. This in part explains the delayed start on trying to pursue the ILMCT agenda for legislative proposals. Even with the cooperation of the Rep. Dent, Chair of the Local Government Committee in the House, we could not locate a bill that under the rules of both chambers could be successfully amended into any bill that was germane or that was intended to affect the same Title of the Indiana code as our proposed legislation.

I wish to commend the ILMCT Legislative Committee, which owing to the pandemic, basically was enabled from the start of immediate past president Karen McQueen's term in July 2019 until the recent election effective August 27, 2021 welcoming our new President, Jane Jordan. I think that our preeminent achievement is successful adoption of legislation that creates a requirement for training for clerks, controllers and clerk-treasurers. Further, that same legislation requires support from all the relevant officers of the municipality in the objectives of the law. The ILMCT is mindful that there is no express penalty for not complying. That was intentional as we wanted to move "incrementally" while demonstrating our self-imposed higher standards to the public and to the Indiana General Assembly. In addition to the training law, there was a needed clarification in the sewage and sanitary district laws, that aligned the timing of delinquencies. This is a commendable and considerable body of work to have seen through. So, we thank Past President Karen McQueen for her support of this committee's work and work product.

The Committee continues to believe that there are some legislative matters that should be addressed as part of the proposal for our work in the short session of the 122<sup>nd</sup> General Assembly. The Committee commends to its successor committee, (which we hope will be comprised of the members of this committee), the following suggestions for the legislative plan moving forward:

- ***Allow employees to be automatically in unless they opt out of Deferred Compensation 457 Plan.*** State law allows state and local governments to offer deferred compensation accounts for its workers. Presently new State employees are automatically enrolled in such a plan unless they opt out. This section merely extends the same provision that applies to states to local government deferred comp plans, if the local body so elects.
- ***Allow deposits to be paid when booking entertainers or ordering a fire truck.*** Current law prohibiting paying before a service or good is delivered is clarified to permit a deposit to be paid to ensure performers or groups of performers to secure the booking at municipally sponsored festivals or events and it allows this as part of the order and purchase of Fire trucks or any personal property in excess of \$150,000 in value.

- **Boards of Finance clarifying** language, intended by the 1997 amendment also sponsored by the ILMCT, that would expressly state that city and town councils have all the powers of the board of finance without having to perform the annual separate organizing meeting; that they may receive investment reports and do all other things that a board of finance does without the formality of an annual organizing meeting and the separate distinct identity as a board of finance – they may perform these activities at any special or regular meeting of the legislative body and remain the legislative body.

While the pandemic is affecting us differently in its current phase, the following ideas still have merit:

- ***Allow Excess levy Fund resources to be used in Declared Emergencies.*** Loss of revenues in the COVID health emergency has challenges us all. This idea from our Tami Runyan might be a partial way to ameliorate the situation in the future. It is suggested to add a new subsection to IC 6-1.1-18.5-17.
- ***Clarify lawful actions with Cumulative Capital Development Fund resources to be used in Declared Emergencies.*** Loss of revenues in the COVID health emergency has challenged us all. The MCCD enabling law currently expressly authorizes that money in the fund may be spent for purposes other than those set forth in its provisions “*if the purpose is to protect the public health, welfare, or safety in an emergency situation that demands immediate action or to make a contribution to an authority established under [IC 36-7-23](#).*” However, it is the position of the State Board of Accounts, that this does not include transferring some of this money to another fund that is depleted owing to the emergency. How about some language to allow transfers to other funds too as part of the emergency uses?

Finally, the following might require enlisting other interested parties before undertaking its purposes:

- ***Language to protect from cutting health benefits if these are offered to other employees who are not elected.*** As we know, in the 2019 session, the State Board of Accounts advocated and Aim as well as ILMCT embraced a well needed clarification regarding compensation for elected officials, who seek to have their pay be changed in any given year based upon added education, or certification. In order to eliminate a concern for changes in insurance premiums that somehow are reduced, insurance premiums were exempted from the annual prohibition to change or reduce. As many of our veteran members know, before this law, many of our colleagues had “retaliatory” reductions to pay first by taking away health insurance. As you may know, lawsuits using the former language successfully recovered and restored the health insurance in many cases. I am not for changing the compensation law as it is really well done and I like the idea of eliminating changes owing to reductions in health insurance creating a claim from an official to get the difference in the premium restored somehow to the official’s compensation. (Proposed changes to IC 5-10-8-2.6 in particular, adding two new subdivisions to protect the health insurance if it is already offered to other employees of the municipality might be a welcome added fix.)

## Legislative report continues ...

Again, I regret my misreading of what the legislature's work product would be during the pandemic. That was my mistaken discernment that delayed us to get our legislation to the correct bodies in time, I think, in the long session just ended. However, I do believe that we have goodwill from the Chair of the House Local Government Committee and I believe contacting our legislators as soon as possible following a meeting of the Legislative Committee should allow for a more prodigious session of desired legislation. Of course the committee should always seek the input of the members for needed legislation.

The committee ends its work as commissioned by the appointment of Past President Karen McQueen. The co-chairs and the members thank her for appointing us to serve the League and its members in this way. We appreciate being able to work to make the legal environment in which we all serve support our best service to our cities and towns. We commend this report to the past president and the new officers. The co-chairs and the members also commend our members to the new ILMCT President, Jane Jordan, for appointment to serve our league as members again or in any way in which she may determine.


