# Q: When can governmental units expect to have their 2007 budget certified?

A: All municipal budgets in Indiana are in various stages of completion. The timing for certification of budgets depends on where your county is in terms of completing ratio studies (trending) and the estimates of assessed values. As of January 29, 62 counties have had their ratio studies approved and 11 have had their assessed values certified. To check the status of your county, view the 2007

Certification Status Map on the Department of Local Government Finance's website at www.in.gov/dlgf.

# Q: Which fund are supplemental distributions of CAGIT, COIT and CEDIT supposed to be receipted to?

A: Supplemental distributions of CAGIT money shall be deposited in accordance with IC 6-3.5-1.1-21.1, which states that the civil taxing unit receiving the money shall deposit the money in the civil taxing unit's rainy day fund.

Supplemental distributions of COIT money shall be deposited in accordance with IC 6-3.5-6-17.3, which states that a supplemental distribution shall be made in January of the ensuing year and allo-

cated in the same manner as certified distributions for deposit in a civil unit's rainy day fund.

Supplemental distributions of CEDIT money shall be deposited in accordance with IC 6-3.5-7-17.3, which states that a supplemental distribution shall be made in January of an ensuing year and allocated in the same manner as certified distributions for deposit in a civil unit's rainy day fund.
