

## **Mary Lynne Stratta, TRMC, MMC 2009-2010 IIMC President**

Dear Friends and Colleagues,

It is a busy time for IIMC. In mid-August, the Budget and Planning Committee will meet to prepare the 2010 IIMC budget to be presented to the IIMC Board of Directors at the mid-year Board meeting. I have charged this committee with preparing a balanced budget and, for the first time in IIMC's history, a three-year financial forecast and multi-year capital needs plan. I believe it is important with the current state of the economy that we plan ahead and that we be as financially conservative as possible. I have been extremely frugal with IIMC's money, using IIMC's bank of frequent flyer miles for my travels, and I have articulated my expectation to the rest of the Board that they be as frugal as possible when traveling on IIMC's behalf. Along that line, I asked that our Conference Planner and Executive Director go out for bids for the site location for the IIMC Board's mid-year board meeting. I had three criteria for the location: 1) Cheap; 2) Cheap; and 3) Cheap! We received an extremely good bid from Albuquerque, NM, and holding our mid-year meeting at that location will bring in the cost of the Board meeting below budget. It also provides the best value for our MCEF Board members, who donate their travel costs to MCEF. I would encourage future IIMC presidents to follow a bid process rather than just selecting a location, as has been the practice in the past. Every dollar we save is a dollar we can redirect to educational endeavors to benefit our members.

At the mid-year meeting, the IIMC Board will continue its work to develop IIMC's first membership-driven long-range strategic plan. The Board will adopt the strategic plan at the Board meeting held in conjunction with the May 2010 conference.

The Program Review/Certification Committee and the Education/Professional Growth Committee have been working extremely hard

to address ongoing issues with the current education guidelines. These two committees will come forward with strong recommendations for the Board to consider at the mid-year meeting (November 6-7). Prior to that, our state education committees and institute directors will be asked to provide feedback regarding the committee recommendations. If you have concerns and/or have experienced problems with the current education/certification guidelines and would like to see positive changes made to improve the program, I would encourage you to articulate those concerns and suggestions to your IIMC Region Directors prior to the mid-year meeting. I am hopeful the Board will take action at the mid-year meeting to correct as many of these issues as possible so that we can move forward with meaningful, achievable, affordable certification for all of our members.

Our Membership Committee has launched the new Region of the Month program. Each region will be featured in an article in the IIMC News Digest. Region V will be featured in the December issue. The Small Cities Task Force will be disseminating a survey to our small city members (less than 1,500 population) in the near future. The Policy Review Committee will be bringing to the Board several recommendations for new policies, changes in policies and proposed IIMC constitutional amendments to make sure that IIMC operates in the most efficient, ethical manner possible.

Using IIMC frequent flyer points, I attended the Institute of Municipal Administrators of South Africa conference held in Polokwane, South Africa, June 16-19. IMASA's objectives and founding values have at their heart the promotion of sound, professional and ethical municipal administration, serving the best interests of the profession of municipal





administration and the development and growth of its members in the profession. IMASA is working to establish an IIMC approved institute in South Africa. IIMC has approved their curriculum plan and IMASA is now working on funding and national government approval of their certification program prior to implementation. I had the opportunity address the delegates twice during the program. I discovered through my visit that the United States and South Africa are more alike than we are different, and that we share many common problems and challenges. I believe my visit helped to strengthen the partnership between IIMC and IMASA and I look forward to signing a new affiliation agreement with IMASA this year. I again want to thank IMASA Past President Selby Gibbs, IMASA President Ria Heitbrink and Host Clerk Barry Viljoen for their warm and gracious hospitality. South Africa hopes to host the IIMC 2011 study tour and I would encourage you to not miss the opportunity to visit this beautiful country and its warm and friendly people.

The IIMC 2009 study tour to Wales/England has met the minimum number of registrants. Additional information about this unique opportunity to learn about local government best practices in other countries is available on IIMC's website ([www.iimc.com](http://www.iimc.com)). The cost is very affordable and there is still an opportunity to participate.

Once again using IIMC frequent flyer points, I participated in the Reno conference site visit in July. We had the honor of meeting Reno Mayor Bob Cashell, who pledged the City of Reno's support to make the conference a rewarding experience for our members. The host hotel, the Grand Sierra Resort, has lowered our conference room rate for a standard room to \$99/night. The Grand Sierra offers a free shuttle service to/from the Reno airport and a wide variety of dining venues from fast food to fine dining. Attendance at the conference should be affordable for our members. Most importantly, the Nevada Institute Director, host committee and IIMC staff are developing an impressive and outstanding educational program for the conference.

**AMCTO AND MAMC CONFERENCE REPORT**

**IIMC PRESIDENT ELECT**


I had the great pleasure and honor to represent IIMC and President Mary Lynne Stratta at the annual meeting of the AMCTO (Association of Municipal Manager's Clerks and Treasurers of Ontario) conference as well as the MAMC (Michigan Association of Municipal Clerks) conference in June.

The AMCTO conference was held in Sault St. Marie, Ontario with 260 participants. The theme of the conference, *Meeting At The Cross Roads*, was chosen as a way to speak to a number of issues that are facing municipal officials. One such cross road is a generational cross road that is seeing a massive influx of young professionals entering the public sector. Another is a critical cross road regarding our environment that has caused municipalities to step to the plate and take a leadership role in the development of conservation practices and of course the cross road of maneuvering our way through this global financial crisis we find ourselves in.

The AMCTO conference was jam packed with educational sessions and networking opportunities for all conference attendees. I had the opportunity to visit with many members of AMCTO and talk with them about IIMC and what we can do to attract them to our organization. Even though AMCTO offers their own certification (certified municipal officer), there are still many benefits that can be realized by belonging to both organizations. I spent a lot of time defining those benefits. Many AMCTO members were very interested in the education that IIMC offers via on-line learning and through the purchase of the CD ROMs. One matter of extreme interest was parliamentary procedure. There was also great interest in the partnership with IMASA and the development of an institute in South Africa. Many of the members I spoke with are facing the same frustrations as those of us in the states – the financial crisis. It is universal and the sharing of knowledge and the lending of ideas on how to make government more efficient and effect seemed to be a resounding theme of conversation.

The highlight of the conference for me was hearing from Mr. Jim Watson, the minister of municipal affairs and housing. He addressed many issues facing Canadians, but his focus of course, was in relation to long term affordable housing. He pointed out that each municipality has a responsibility to address affordable housing and that status quo is not an

option. One statement he made that hit home to me was, the sign of a true society is how we treat our most vulnerable. He noted that \$1.2 billion dollars have been allocated to housing. The message to the delegates was loud and clear – their government is doing all they can to assist their citizens with their housing and poverty issues.

I left Sault St. Marie, Ontario and headed to the beautiful City of Frankenmuth, Michigan to visit with the Michigan clerks during their annual meeting. Although my time there was less than 24 hours, it was great for IIMC to be represented at the MAMC conference and I loved being among fellow region v members.

I had the chance to address the attendees during their "Clerk of the Year" banquet. As a member of Region V, going to Frankenmuth was like going home! I have a special place in my heart for the Michigan Clerks and it was a great pleasure for me to be a part of their program. The theme for their conference was "***Back to Basics and Beyond.***" As with AMCTO, the MAMC conference was full of educational sessions that were designed to be thought provoking and to provide relief in knowing that you are not alone while performing your duties. The Michigan Clerks are a very proud group of individuals who take great pride in their profession. They work tirelessly to guarantee their elections are run in the most effective and efficient manner possible so as to provide faith in government to their residents. They take their oath very seriously and it is always a pleasure for me to be with them. Of course, you know that I'm a Buckeye so it's always fun for us to share some "spirited" rivalry jabs back and forth. Go bucks!!

In July, I had the pleasure of attending the Kentucky Municipal Clerks Institute. Barbara Combs, Institute Director and a great friend to IIMC, asked if I would do a session for their attendees on the advantages of membership in a Professional Association. That gave me an opportunity to speak to over 60 participants about the many services and benefits that IIMC has to offer. I also had the privilege of addressing the members and their guests at the Annual Banquet and was pleasantly surprised by being named a Kentucky Colonel. This is the highest honor awarded by the Commonwealth of Kentucky. Their Colonels are Kentucky's ambassadors of good will and fellowship around the world. Other Colonels include: President Lyndon B. Johnson, Prim Minister Winston Churchill, John Glenn, Ann Margaret, Tiger Woods, and Dwight Yoakam.

It was a great honor for me to represent IIMC and President Stratta at the AMCTO, and MAMC annual conferences as well as the Kentucky Institute. I enjoyed the opportunity to visit with all three associations and extend my sincere thanks for the hospitality shown to me.

Here is what's happening in Ohio:

The Ohio Municipal Clerks Career Development Institute, like most other State's, is dealing with budget challenges. Our Institute remains a priority to Kent State and the Ohio Municipal Clerks Association. Together we are looking at cost saving measures and alternate funding sources.

## **STATE REPORTS**

**Indiana** - Larry Breeze, President of the ILMCT, presented Nashville, TN with a check for \$1,000 for the 2011 IIMC Conference and announced that the last Institute had over 100 in attendance.

**Kentucky** – President Debbie Batliner announced that they are starting a master's program for Kentucky Clerks and they were working hard to encourage continuing education by their members.

**Michigan** – President Ann Ulrich announced their upcoming conference would be held in Frankenmuth, MI and that their membership was up to 740.

**Ohio** – President Diane Jamison announced that the Ohio Clerks held a silent auction and raised \$720.00 to help the Tennessee Clerks with the 2011 conference. Also that the Ohio Clerks Institute was switching over to Kent State.

**Tennessee** – President Shirley Dancy welcomed all Region members to help with fund raising ideas for the 2011 conference. A lot of money is needed to be raised by the sponsoring city to hold an international conference of this size.

**Region V Director** – Tami Kelly, Ohio, was introduced as the incoming Region V Director, replacing Kathy Dornan whose term would end during the annual conference.

Region Directors Kathy and Brenda reported the following from the IIMC Board meeting:

- Lance Deckard, strategic planner is working with the IIMC Board to address areas of concerns. All litigations have been resolved and adjustments have been made to ensure that we take appropriate action going forward.
- CMC applications are now caught up.
- MMC applications are now receiving extra help in processing.
- Going forward we should see a much shorter processing time for all applications.
- IIMC will be cutting budget due to the decline in the economy.
- IIMC has 862 delegates in attendance this week with over 50% located in Region V, VI & VII.
- IIMC has 10,100 memberships.
- There is currently a push for new memberships among regions.
- IIMC annual conference schedule:

  - 2011 Nashville, TN
  - 2012 Portland, OR
  - 2013 Atlanta, GA

Tami Kelly reported on the International Exchange Scholarships that are available to any delegate.

**GREETINGS FROM GROOVY GROVE CITY, OHIO.**


