Question: : I'm still fuzzy about the upcoming changes to how capital assets, depreciation, and debt are reported. Can you explain?

Answer: Changes to 2019 Annual Financial Report (AFR):

Debt – Debt has previously been included in your financial statements as supplementary information. For 2019, it will now be reported as a note to the financial statements. In the AFR for 2019, you will need to report the Jan 1, 2019 debt balance; additions/debt issued in 2019; reductions/principal paid in 2019; and the Dec 31 outstanding debt balance.

Capital Assets – The supplementary schedule of capital assets will no longer just have the Dec 31 balance – you will be reporting the Jan 1, 2019 balance by category; additions in 2019; reductions in 2019; and the capital asset balance by category at Dec 31. No depreciation will be reported at this time.

Changes to 2020 Annual Financial Reports (due March 1, 2021):

Capital Assets – The supplementary schedule of capital assets will be deleted and the capital asset information will be reported as a note to the financial statements. In addition, you will be reporting accumulated depreciation for depreciable assets.
