

The primary mission of the Indiana Bond Bank (IBB) is to assist local government units (LGUs) in obtaining lowcost financing for their operations. The IBB has developed several programs tailored to your specific financing needs.

Through the Hoosier Equipment Lease Purchase (HELP) Program, LGUs can lease-purchase essential equipment and utilize tax-exempt interest rates. Since its beginning in 1989, the HELP program has assisted more than 200 communities in obtaining over \$190 million in equipment by offering competitive interest rates and a streamlined application process. Your LGU will not need to bid the financing if you use the IBB to lease-purchase your equipment. Your entity, however, will still need to follow current procurement laws. If you would like a HELP application or an interest rate quote to lease-purchase equipment, please contact Cindy Burres, IBB'S Office Manager and HELP Coordinator, at 800-535-6974.

The Advance Funding Program (AFP), which was developed to meet LGUs cash flow needs, allows your entity to borrow against property taxes, including any needs you may have for the first half of the 2011 calendar year. The IBB will pool your note with other entities, and in turn, provide lower interest rates to all participants. For example, the 2010 AFP's interest rate was 0.98%! If you are anticipating a cash flow deficit in the first half of 2011, please contact Ryan Dunn, IBB's Program Operations Coordinator, at 800-535-6974. The AFP's application will be available in late August and September of 2010.

The IBB offers these and other programs based on LGUs' financing needs. I encourage you to find out more about these programs on the IBB's website at <u>www.in.gov/bond</u> or by calling the IBB staff at 800-535-6974. I want to see you and your LGU be successful, and I truly believe that the IBB can assist with your efforts.

There is no recourse but to consider the two initiatives during the 75th Annual Conference next June.

#### **Education Notes from Janet Jaros**

It is hard to believe we are already halfway through 2010. We have just finished having a very successful ILMCT Conference and State Board of Accounts School in June. Monday's education class had 168 registered participants. It was wonderful to award 19 IAMC certificates, 5 CMC certificates and 10 MMC certificates at the annual banquet. At this time, we currently have a total of 143 IAMCs, 52 CMCs, 21 MMCs and 9 CPFAs. Kay and I are so proud of all the new recipients. In March we had 140 participants for the Institute and Academy. There has been concern that people will not be able to attend due to budget shortfalls. The fact that the



numbers have not dropped is a tribute to the wonderful dedicated people we have performing the duties they were elected or appointed to for this office.

About 13 of us went to Reno for the IIMC International Conference in May. IIMC has made some very positive changes to their requirements. There were many concerns in the past and they listened to our concerns. One of those changes is that you no longer have to re-certify the CMC certification. Those who did re-certify will be allowed 20 points towards the MMC certification. Those who had their CMC rescinded, due to not re-certifying, will be able to have your CMC reinstated. There is a form on the IIMC website that you can download, fill it out and send it back. If you have any questions concerning these changes, you can e-mail or call IIMC. As we move forward in these continuing tough times, I truly believe we need to educate ourselves, interact with each other often, ask questions and know there is always help available from this wonderful organization.

we just sell it to the individual?

A Assuming the piece of equipment has an estimated value of less than one thousand dollars (\$1,000), IC 5-22-22-6 provides that the Town may sell the property at public or private sale or transfer the property without advertising. Further, IC 5-2-22-8 states that if the property is worthless, it may be demolished and/or junked.






# 2010 IIMC ANNUAL CONFERENCE
